

**Central Water Authority (Water Supply for Non-Domestic Purposes)  
(Amendment) Regulations 1998**

**GN No. 114 of 1998**

**THE CENTRAL WATER AUTHORITY ACT  
Regulations made by the Central Water Board under section 49  
of the Central Water Authority Act**

1. These regulations may be cited as the Central Water Authority (Water Supply for Non-Domestic Purposes) (Amendment) Regulations 1998.

2. In these regulations—

“principal regulations” means the Central Water Authority (Water Supply for Non-Domestic Purposes) Regulations 1992.

3. The First Schedule to the principal regulations is amended —

(a) in item 1, in the heading, by deleting the words “41 and 71” and replacing them by the words “41, 71, 21 A, 22A, 31 A, 41A and 71A”;

(b) in item 2, in the heading, by deleting the words “51 and 71” and replacing them by the words “51, 71, 2 1A, 22A, 31 A, 41A, 51A and 71A”;

(c) by deleting item 3 and replacing it by the following item —

3. WATER RATE where VAT is payable or exempt in accordance with the Value Added Tax Act 1998, and which shall be rounded to the nearest rupee —
