

Central Water Authority (Water Supply for Domestic, Commercial and Industrial Purposes) (Amendment) Regulations 1974

GN No. 55 of 1974

Regulations made by the Central Water Authority under section 49 of the Central Water Authority Act, 1971

1. These regulations may be cited as the Central Water Authority (Water Supply for Domestic, Commercial and Industrial Purposes) (Amendment) Regulations 1974, and shall be read as one with the Central Water Authority (Water Supply for Domestic, Commercial and Industrial Purposes) Regulations 1972 hereinafter referred to as the principal regulations.

2. Regulation 2 of the principal regulations is amended in the definition of "month" by inserting the words "and water rate" immediately after the words "matter rent"

3. Regulation 4 of the principal regulations is amended by revoking subparagraph (3) (c) and replacing it by the following subparagraph-

(3) (e) Subject to subparagraph (d), a consumer to whom water is supplied by means of a prise shall be entitled, per month, to receive not more than-

- (i) 70 cubic metres, free of charge, in the case of a consumer in Port Louis who was the owner of concession prise before the 1st July, 1969;
- (ii) 85 cubic metres in the case of a prise acquired before the coming into force of Ordinance No. 26 of 1891;
- (iii) 50 cubic metres in the case of a prise acquired after the coming into force of Ordinance No. 26 of 1891 but before the 14th January 1895;
- (iv) 35 cubic metres in every other case.

4. Regulation 9 of the principal regulations is revoked and replaced by the following regulations-

(9) (1) Subject to regulation 4 (3) (e) (i) and to paragraph (3), every consumer shall pay the water charges set out in the Second Schedule.

(2) Every consumer to whom water is supplied in accordance with regulation 4 (3) (e) shall pay the water rate in advance in respect of each quarter.

(3) Every consumer whose water supply is measured by a meter shall-

- (a) pay a minimum monthly charge of one rupee and twenty three cents for water rate;
- (b) pay in advance for three months, the meter rent and the minimum charge specified in subparagraph (a).

5. The Second Schedule to the principal regulations is amended by deleting item 2 (1) (a) (ii) and replacing it by the following item-

2 (1) (a) (ii) non-domestic purposes-

from former water supply undertaking of the Municipality of Port Louis-
Rs 0.18 per cubic metre;
from former water development branch of the Ministry of Works
for the first 335 cubic metres per month, Rs 0.21 per cubic metre;
for the second 335 cubic metres per month, Rs 0.16 per cubic metre;
for any amount over 670 cubic metres per month-above filter beds Rs 0.16
per cubic metre, below
filter beds Rs 0.11 per cubic metre.

6. These regulations shall be deemed to have had effect from the 1st day of April 1974.
