

**Central Water Authority Water Supply for Non-Domestic Purposes) (Amendment)
Regulations 1988**

Regulations made by the Central Water Board under section 49 of the Central Water Authority Act

1. These regulations may be cited as the Central Water Authority Water Supply for Non-Domestic Purposes) (Amendment) Regulations 1988.
2. In these regulations-

"principal regulations " means the Central Water Authority (Water Supply for Non-Domestic Purposes) Regulations 1980.
3. The Second Schedule to the principal regulations is repealed and replaced by the Schedule to these regulations.
4. These regulations shall come into operation on 16 May 1988.

Made by the Central Water Board on 3 May 1988, and approved by the Minister on 4 May 1988.

1. Vegetable and Flower Growers and Livestock Producers
 - (a) minimum charge ... Rs 50.00 per month
 - (b) the first 100 cubic metres ... Rs 5.00 per cubic metre
 - (c) each additional cubic metre over 100 cubic metres ... Rs 6.50 per cubic metre

2. Government Departments, Parastatal Bodies and Religious Institutions approved by the Minister-
 - (a) minimum charge ... Rs 100.00 per month
 - (b) the first 100 cubic metres ... Rs 6.00 per cubic metre
 - (c) each additional cubic metre over 100 and up to and including 250 cubic metres . Rs 7.00 per cubic metre
 - (d) each additional cubic metre over 250 cubic metre ... Rs 8.20 per cubic metre

3. A public fountain ... Rs 1,200.00 per month

4. Water supplied to a ship ... Rs 10.00 per cubic metre

5. A stand pipe ... Rs 250.00 per month

6. Prise supply .. Rs 100.00 per month for each prise

7. Other Non-Domestic Consumers-
 - (a) minimum charge ... Rs 100.00 per month
 - (b) the first 100 cubic metres ... Rs 6.00 per cubic metro
 - (c) each additional cubic metre over 100 and up to and including 250 cubic metres ... Rs 6.50 per cubic metre
 - (d) each additional cubic metre over 250 cubic metres ... Rs 7.25 per cubic metre

8. Concessionary/Acquired Prise Supply

(i) in the case of a concession prise acquired in Port Louis before the 1st July, 1969, in respect of the first 70 cubic metres Free
(ii) in the case of a prise acquired before the commencement of Ordinance No. 26 of 1891, in respect of the first 85 cubic metres Rs 50.00 per month
(iii) in the case of a prise acquired after the commencement of Ordinance No. 26 of 1891, but before the 14th January 1985, in respect of the first 50 cubic metres ..	Rs	50.00 per month
(iv) in the case of every other prise	...	Rs 85.00 per month

(v) in the case of a metered prise the excess over
the water allowed under 8(i), (ii), (iii) and (iv)
above ... Rs 6.00 per cubic metre
