

**Central Water Authority (Water Supply for Domestic, Commercial and Industrial Purposes) (Amendment) Regulations 1979**

GN No. 167 of 1979

**Regulations made by the Central Water Board under section 49 of the Central Water Authority Act, 1971**

1. These regulations may be cited as the Central Water Authority (Water Supply for Domestic, Commercial and Industrial Purposes) (Amendment) Regulations 1979.

2. In these regulations-

"principal regulations" means the Central Water Authority (Water Supply for Domestic, Commercial and Industrial Purposes) Regulations 1974.

3. The Second Schedule to the principal regulations is repealed and replaced by the Schedule to these regulations.

4. These regulations shall come into operation on the 1st August 1979.

Made by the Central Water Board on the 27th April 1979 and approved by the Minister on the 24th July 1979.

SECOND SCHEDULE

1. DEPOSITS

(a) Meter Supply-

¾ inch	600
1 inch	1,200
1½ inches	2,400

3 inches	9,600

(b) Prise Supply-

2. METER RENT

Size of meter	Rs
½ inch o ¾ inch	1
1 inch	3
1½ inches	6
2 inches	10
3 inches	20
4 inches	30

3. WATER RATE

(1) supply measured by a meter	Rs
(i) where consumption does not exceed 10 cubic meters	40 for each cubic metre
(ii) where consumption does not exceed 25 cubic metres	1.00 for each cubic metre
(iii) where consumption does not exceed 50 cubic metres	1.50 for each cubic metre
(iv) where consumption does not exceed 100 cubic metres	1.80 for each cubic metre
(iv) where consumption exceed 100 cubic metres	2.50 for each cubic metre

Non-Domestic

(i) where consumption does not exceed 100 cubic metres	2.00 for each cubic metre
(ii) where consumption exceeds 100 cubic metres	2.00 for each cubic metre

(2) Prise Supply

(a) in the case of a concession prise acquired in Port Louis before the 1st July 1969, in respect of the first 70 cubic metres	FREE
(b) In the case of a prise acquired before the commencement of Ordinance No. 26 of 1891, in respect of the first 85 cubic metres	1.00 per cubic metre
(c) In the case of a prise acquired after the commencement of Ordinance No. 26 of 1891 but before the 14th January, 1895, in respect of the first 50 cubic metres	1.00 per cubic metre
(d) In the case of every other prise- (i) for a domestic supply (ii) for a non-domestic supply	32.00 per month 64.00 per month
(e) In the case of a metered prise, the excess over the water allowed under regulation 4(3) (c) (i), (ii), (iii) and (iv) shall be paid for at the appropriate rate set out in item 3(1)	

(3) Public fountains

In the case of a public fountain 250.00 per month.
